Contact with asbestos and its removal is heavily regulated and specifically related legislation includes the Control of Asbestos Regulations 2006. Under Regulation 4 the 'Duty to Manage' there is a responsibility on building owners, landlords and agents to manage the risk from materials containing asbestos in their premises.

Legislation – the Duty to Manage

Regulation 4 of the Control of Asbestos Regulations 2006 places responsibilities on the duty holder to manage asbestos in non-domestic premises.

The duty holder has a responsibility to:

- Identify asbestos containing materials (ACMs) present
- Assess the risk posed by ACMs
- Prepare a detailed written plan on how to manage the risk
- Implement the plan
- Review and monitor to ensure ongoing compliance
- Inform those who need to know of the location and condition of ACMs

Asbestos Surveys, Sampling and Assessment

Management and refurbishment/demolition asbestos surveys can be undertaken adhering to the latest HSE guidance.

Statutory Re-inspections

ESG's qualified surveyors will perform a thorough visual inspection of the asbestos containing materials identified in the asbestos register. Risk changes are recorded and the management plan updated. Recommendations for new control measures are given where required.

Sampling and Material Identification in UKAS accredited laboratories

With UKAS accredited laboratories across the UK, ESG can undertake asbestos bulk sampling and analysis in accordance with ISO17025 and the techniques set out in HSG248.

Air Monitoring and 4-stage Clearance

The ESG asbestos teams provide a complete inspection and airborne fibre monitoring service including reassurance inspections and air quality monitoring, personal exposure and 4-stage clearance testing for certificates of re-occupation following asbestos removal, in accordance with HSG248. There is also a 24/7 emergency call-out service available.

Project Management of remedial/removal work including Tender Specifications and Site Supervision

ESG offers independent Project Management of asbestos removal from the specification and tender stages, through to the management of the removal stages. This includes air testing, 4-stage clearance activities and issuance of the certificate of re-occupation.
